### SECTION 4. FIRST AID MEASURES

#### Description of first aid measures:

**In case of inhalation:** If inhaled, remove to fresh air. If not breathing, give artificial respiration. Get medical attention immediately.

**In case of skin contact:** In case of contact, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse. Thoroughly clean shoes before reuse. Get medical attention.

### SECTION 5. FIRE -FIGHTING MEASURE

#### Extinguisher media:

**Suitable extinguisher media:** Carbon dioxide, foam dry chemical and water fog.

**SMALL FIRE:** Extinguish small fires with carbon dioxide, dry powder, or alcohol-resistant foam.

**LARGE FIRE:** Water spray can be used for larger fires or cooling of unaffected stock but avoid the accumulation of polluted run-off from the site.

### SECTION 12. ECOLOGICAL INFORMATION

#### Degradability:

Glyphosate is moderately persistent in soil, with estimated half-life of 47 days. Microbes are primarily responsible for breakdown.

Glyphosate is strongly adsorbed to suspended organic and mineral matter in water, and broken down primarily by microbes. Half-life ranges from 12 days to 10 weeks.

#### Mobility:

The product is practically immobile. It is strongly absorbed to most soils. It does not leach appreciably, and has low potential for runoff.

#### Accumulation:

The product shows little or no tendency to bioaccumulate and poses no long term threat to wildlife.
