SECTION 4. FIRST AID MEASURES

Description of first aid measures:

In case of inhalation: If inhaled, remove to fresh air. If not breathing, give artificial respiration. Get medical attention immediately.

In case of skin contact: In case of contact, immediately flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse. Thoroughly clean shoes before reuse. Get medical attention.

In case of eye contact: Check for and remove any contact lenses. In case of contact, immediately flush eyes with plenty of water for at least 15 minutes. Cold water may be used. Get medical attention.

In case of ingestion: Do NOT induce vomiting unless directed to do so by medical personnel. Never give anything by mouth to an unconscious person. Loosen tight clothing such as a collar, tie, belt or waistband. Get medical attention if symptoms appear.

Most important symptoms and effects, both acute and delayed:

Anticipated acute effects:

May be harmful in contact with skin.

Causes mild skin irritation.

May cause an allergic skin reaction.

Anticipated delayed effects:

May cause damage to organs.

Most important symptoms / effects: None known.

SECTION 5. FIRE -FIGHTING MEASURE

Extinguisher media:

Suitable extinguisher media: Carbon dioxide, foam dry chemical and water fog.

SMALL FIRE: Extinguish small fires with carbon dioxide, dry powder, or alcohol-resistant foam.

LARGE FIRE: Water spray can be used for larger fires or cooling of unaffected stock but avoid the accumulation of polluted run-off from the site.

Unsuitable extinguishing media: Do not use high volume water jet, due to contamination risk.

Special hazards arising from the mixture:

During a fire, irritating and possibly toxic gasses may be generated by thermal decomposition or combustion. Closed container may explode if pressure builds up. Toxic or irritating gas may be generated during fire.

Advice for fire-fighters:

Fire fighters should wear positive pressure self-contained breathing apparatus (SCBA) and full turnout gear. Be sure to use an approved/certified respirator or equivalent.

SECTION 6. ACCIDENTAL RELEASE

Personal precautions, protective equipment and emergency procedures:

For non-emergency personnel: Isolate area. Keep unnecessary and unprotected personnel from entering the area. Refer to Section 7, Handling, for additional precautionary measures. For emergency responders: Use an approved/certified respirator or equivalent, isolate the spill area and limit the access to emergency responders only. Avoid any contact with spilled material, use adequate protective clothes and gloves.

Methods for containment and cleaning up:

For small spills Contain spilled material if possible. Collect in suitable and properly labelled containers. Absorb with materials such as: sand, earth, vermiculite or diatomaceous earth.

For large spills Prevent entry into sewers, water courses, basements or confined areas. Wash spillages into an effluent treatment plant or proceed as follows. Contain and collect spillage with non-combustible, absorbent material e.g., sand, earth, vermiculite or diatomaceous earth and place in well labelled container for disposal according to local regulations.

SECTION 7. HANDLING AND STORAGE

Precautions for safe handling:

Use adequate protective equipment to avoid direct contact of product. Eating, drinking and smoking should be prohibited in areas where this material is handled, stored and processed. Exposure control:

Carcinogenicity: Early experiments on animals indicated that **Trifluralin** was carcinogenic. This has since been found to be due to an impurity, di-n-propylnitrosamine, a known carcinogen, present in crude **Trifluralin** at about 80 to 100 ppm. Thus **Trifluralin** itself is considered to be non-carcinogenic.

Teratogenicity: Not teratogenic.

Mutagenicity: Not mutagenic.

SECTION 12. ECOLOGICAL INFORMATION

Degradability:

Trifluralin is of moderate to high persistence in the soil environment, depending on conditions. Trifluralin is subject to degradation by soil microorganisms. Trifluralin remaining on the soil surface after application may be decomposed by UV light or may volatilize. Reported half-lives of trifluralin in the soil vary from 45 to 60 days to 6 to 8 months. After 6 months to 1 year, 80 to 90% of its activity will be gone. It is strongly adsorbed on soils and nearly insoluble in water. Adsorption is highest in soils high in organic matter or clay content.

Trifluralin is nearly insoluble in water. It will probably be found adsorbed to soil sediments and particulates in the water column.

Following oral administration in animals, 70% is eliminated in the urine and 15% in the faeces within 72 hours.
